# **DESIGN BUILD**

Spectrum Contracting Services, Inc. believes the most efficient method of delivering a construction project is through the utilization of Design Build. In this section of our data book is a discussion of the contracting arrangements for the construction industry with their advantages and disadvantages. A review of that information indicates that Design Build delivery of construction projects is the fastest growing form of construction. It further projects the continued growth of this product delivery over the foreseeable future. The reasons are many but three of the most noteworthy are cost savings (usually 10% or more), time savings (usually 25 to 30 percent faster than traditional construction), and increased total quality of the project due to the partnering relationship between the Owner, Designer and Contractor.

With 41 years of construction experience as the President and CEO of a commercial contracting firm, I have come to understand that all highly successful projects involve a harmonious relationship between the Owner, Architect / Engineer, and the Contractor. Whenever these entities work together for the good of the project, the final product offers the highest quality in the least time at the most efficient cost for the benefit of the Owner. The Owner, the Architect and the Contractor enjoy the process due to the partnering concept wherein creative ideas, cost containment and good will are prevalent. This attitude and commitment to a successful project enhances the project and the joy of all parties for having been involved in the project.

To properly facilitate a successful design build project, the designer and the builder are required to have professionalism and extensive experience in the design build industry. All General Contractors are not appropriate for design build. The best General Contractors for design build are Contractors who have engineering professionals on staff as well as business professionals. This means the Contractor must have an educated group of employees who function as professionals. Furthermore, it is essential that the Contractor have experience in design build.

Spectrum has or is involved in 60 design build projects over the past five years. These projects have met budgets and delivered client satisfaction. Client satisfaction is demonstrated by our continued growth in the design build segment of the construction industry as the Contractor of choice. Our reputation is such that we have been chosen as the design builder for projects as far away as Tampa, Florida to the South and Nashville, Ohio (close to Cleveland, Ohio) to the North. 




